Grant Activity - Riparian Management-2016 Equipment			
<b>Description</b>	Riparian Management-2016 Equipment Funds will be spent by the SWCD to purchase a Trimble survey grade equipment R8 or R10 to increase capacity of staff to implement buffers and other erosion control projects. The District will also be utilizing other local funds to cost share the purchase of the equipment. The equipment will be used on projects identified in the County Comprehensive Local Water Plan. Funding will also be used toward the purchase of a new truck.

This includes the purchase of a Trimble GPS unit, purchasing supplies, and updates the SWCD board and commissioners on progress.

<b>Actual Results</b>	Funds were used for a technician and staff to build capacity in working with landowners on implementation conservation practices and promoting especially practices in riparian areas in Pope County. Pope SWCD coordinated efforts with the Pope County Land and Resource Management Office and RMB labs to take all monitoring data collected and complete 2 page trend analysis reports on all the major lakes in the county monitored. There were a total of 12 2 page lake trend reports completed. RMB then also compiled them into a County Summary Report which was paid in part by District Capacity Funding.
