-Keith Nygaard asked if anyone would like to address the board at this time. Earl Hauge attended the meeting and asked to address the board. Nygaard indicated that the board sets aside 15 minutes under public comment on our agenda for the public to address the board and then gave Mr. Hauge the floor to address the group. Mr. Hauge referenced his letter that he submitted to the board prior to the meeting. Most of his discussion was taken from that letter. He shared that he sees that the implementation of WCA puts the authority in the hands of the

local committee and to find a reasonable solution. He stated that he believes that the law is what the County Committee says it is. This is as he sees the law. He stated he believes his point of view is the right one. He stated he sees that the Pope SWCD Board is committed to following the law. Then he stated, "what is the law?" He followed that by saying the law is what Pope SWCD says it is.

Reents shared that the #1 thing is to avoid wetlands if possible. Kovarik shared first you avoid. If you cannot avoid impacts to a wetland you minimize the impact. Lastly you can mitigate or pay to offset the impacts created through buying wetland credits. Mr. Hauge shared that he already understood this.

Mr. Hauge stated landowner rights were taken away from wetland owners with this law. There was some concurrence on this statement that when this law was passed it made it so you could not just go in and impact wetlands. Kovarik shared that this law happened because we have lost so many of the wetlands in our state since the 1800's. Wetlands are an important resource that now has some protections. D. Gary Reents stated there are other things you cannot do because there are laws in place that provide protections. You cannot kill was one example given there are laws in place that if you do this it would be a violation of the law. You would go to jail. Randy Pederson shared that there are processes in place to work with the law and these have been explained to Mr. Hauge. While you may not be able to do anything you want in the wetland there is a way to minimize or mitigate impacts and processes have been laid out to landowners in those situations.

Nygaard stated that we have used all the public comment time. Mr. Hauge shared that he knows he cannot go into any wetland and change it unless he has worked through the Wetland Conservation Act with staff in our office.

Mr. Hauge was displeased with his amount of time to address the board. Nygaard shared that the board has heard from Mr. Hauge many times on this topic. Mr. Hauge had an outburst of inappropriate behavior and stated do we need to sue the SWCD? Randy Mitteness stated that the board has heard nothing new to change their minds. He also stated we are already in litigation with Mr. Hauge and that at this time there is nothing further that the SWCD Board can do regarding this matter. Mr. Hauge stated he held no hard feelings toward the board and left the meeting.

- 14.
