Actual Results

The funds are being used for staff implementation of the Buffer Law. This includes review of maps, site visits, and associated paperwork tracking and reporting the implementation. This will include staff time with alternative practices and the review and verification of parcels with new County imagery. This will also include assistance for any landowner implementing practices that will enhance the effectiveness of a required buffer. Pope SWCD has just completed a complete review of all parcels using the most current imagery. We have 8 sites considered non-compliant and we are working on notifications to the County, State, and landowners. We will be using these funds in 2023 to do this work.

The funds are being used for staff implementation of the Buffer Law. This includes review of maps, site visits, and associated paperwork tracking and reporting the implementation. This included staff time with alternative practices and the review and verification of parcels with new County imagery. This also included assistance for any landowner implementing practices that will enhance the effectiveness of a required buffer. Pope SWCD completed a review in Fall of 2022 of all parcels using the most current imagery. As of 12/31/22 8 sites were considered non-compliant, and we worked on notifications to the County, State, and landowners. We identified an additional non-compliant site the end of 2023. As of 12/31/2023 we currently have two non-compliant buffers. We assisted four producers with seed and seeding through our Sales Program. We flagged 7 sites for landowners per request. We compiled the finding of fact document for the County for the sites under enforcement. We had a total of about 198 hours' worth of work this year. We had one that went through enforcement and was in Conciliation Court to gain compliance. This landowner did comply this fall and we submitted a notice to the County of Validation of Compliance. We have one other violation that is in enforcement and currently beyond the 11-month grace period and accruing fines. This site will likely end up in court as well to comply.
