## **Actual Results**

Pope SWCD staff has worked with DNR on 6 enforcement situations. Resource protection notices have been issued. Two sites have been resolved with a Notice of Successful Restoration. The other 4 are still pending. We have one active appeal being reviewed by the state. Types of Applications Approved: 5 Boundary and Type, 5 No Loss, 4 Exemptions, 1 Replacement plan. Types of Applications denied: 1 No Loss and 1 Replacement Plan. We have one potential violation that is being investigated currently. The number of Landowner contacts 181 above are mostly inquiries about WCA and what would be allowed under the provisions of the Statute and rule. We have 50 landowner/projects that we have documented reviewing in 2023. Most of them find ways to avoid wetland impact. Pope SWCD also worked on transition of the LGU responsibilities to Pope County LRM for 2024. The WCA Reporting Form for accomplishments has been delayed. The accomplishment report will be submitted as required when the template is available. This report should meet our needs for the financial reporting for the program.
